- It is possible to attend the Campus as participant student or as an auditor
- The students enrolled can attend daily lessons of the masterclass of one or more professors.
- A piano, placed in various classrooms, will be made available for practice to all students accompanied by the tutor.
- At the end of the Campus, a certificate of attendance will be issued to all students. Participant students will play in the final concert.

Enrolment fees

- The enrolment fee for each participant student is Euro 200.00 (net of any commission charged by the bank when sending and/or receiving the wire transfer), inclusive of actual enrolment fee (Euro 185) and membership fee to the Associazione Musicisti of Ferrara (Euro 15.00).
- The enrolment fee for auditors is Euro 250.00 (net of any commission charged by the bank when sending and/or receiving the wire transfer), inclusive of actual registration fee (Euro 235) and membership fee to the Associazione Musicisti of Ferrara (Euro 15.00).
- The attendance fee to the Campus for participant students is Euro 1,000.00 (one

thousand)

How to apply

- All applications must reach the administration office of the Associazione Musicisti of Ferrara by e-mail (amfscuoladimusica@fastwebnet.it) **no later than June 10, 2017**. Applications shall include the following: first name and surname, place and date of birth, address, phone number, e-mail address, authorization to process personal data, list of authors that each student wishes to study.
- The application shall also include the payment receipt of the enrolment fee (Euro 200 for participants and Euro 250 for auditors) that shall be paid by bank transfer at Cassa di Risparmio di Ferrara (IBAN IT51M0615513000000000031290) in favour of Associazione Musicisti of Ferrara. The reason for payment box shall be filled in writing student's name, Surname-Masterclass.
- Participant students must pay the participation fee (Euro 1,000.00) **by June 20, 2017** and as detailed in the previous paragraph.

Note: the Campus will only be activated with minimum eight participant students. Otherwise the Campus will be suspended and the enrolment/attendance fees will be refunded. In the event of renunciation/cancellation only the participation fee will be refunded.
